The Westacres community is just that, a community. This very unique neighborhood was established in 1936 by James Couzens as low income housing. Because, in the early years, our location was in the "boondocks", Westacres residents found creative ways to work around this issue. A fire department, a credit union, a food co-op, a library, a full weekend family event called Aquacade, many social clubs and a weekly newspaper are just a small example of how the residents pulled together. Many of these and more still exist today.

Along the way, on March 30, 1968 to be exact, the first Artist Market was held. Ever since, talented artists have been sharing their media with the public at this event. The Artist Market is a fine arts show sponsored by The Westacres Women's Club. It is located inside and outside of our community house with a backdrop of Middle Straits Lake.

*Jury Information:*

This is a juried fine arts show. Exhibitors are selected on quality and originality of their work. The jury is comprised of individuals with strong backgrounds in the visual arts. The jury process is anonymous. Our goal is to invite a diverse range of artists with broad representation of art media and creativity.

*Entry Requirements:*

- Please completely fill out and detach the application and waiver.
- Submit three (3) images of your work and one (1) image of your booth/display fully stocked. (All images are preferred in JPEG format on CD)
- Include a self-addressed adequately stamped envelope for the return of your CD if desired.
- Please include two (2) separate checks. One with the non-refundable jury fee of \$10.00 and the other with your booth fee of \$75.00, made payable to: **Westacres Women's Club.**

*Booth Information:*

- This is an indoor and outdoor art show.
- Outdoor booth spaces are 10'x10'.
- Indoor booth spaces vary in size. Demensions for your booth will be included with your set up information.
- Placement of artists is at our discretion, but we try to honor your request whenever possible.

*Artist Regulations:*

- 1) Artists must be ready for business at 10am and remain open for the full duration of the show. No Exceptions.
- 2) Booth assignments are at the sole discretion of the Artist Market Chairpersons.
- 3) All artists must be present with their art work at all times. A hostess will be available to watch your booth while you enjoy a lunch we provide for you.
- 4) All work presented must be hand created by the artist. No commercial items of any kind will be allowed to be sold or displayed. Final determination of commercial items will be made by the Artist Market Chairpersons. Jewelers must be designers and hands-on makers of their own work. Please note in your description if your beads are hand made or not.
- 5) Each exhibitor is responsible for collection and payment of 6% Michigan Sales Tax.
- 6) Absolutely **NO REFUNDS** after Notification.
